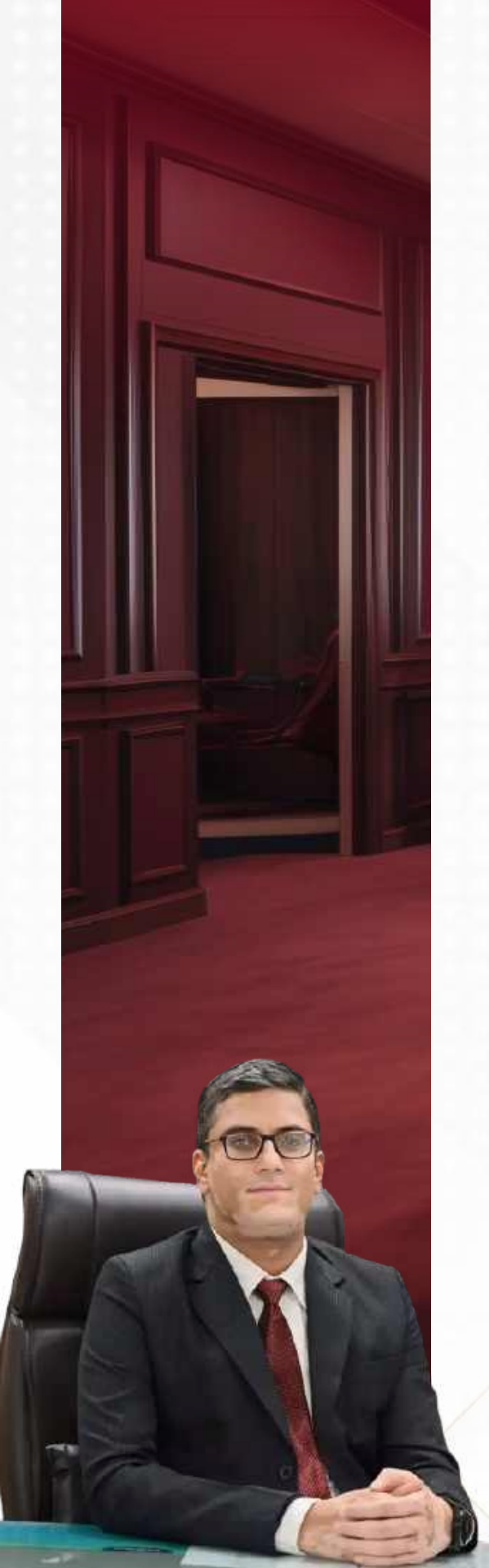

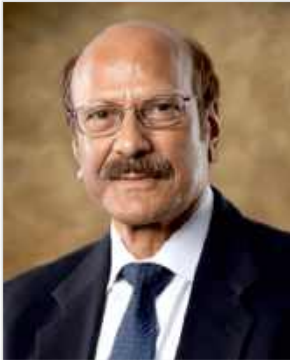

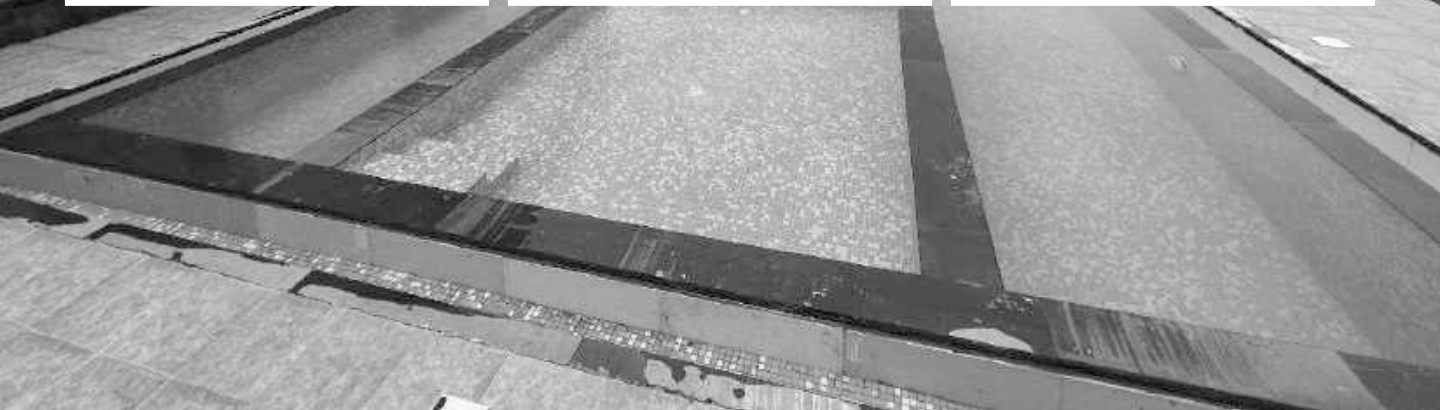

Madam/Sir,

Kindly refer to letter No. PCU/R/UGC/2022-23/31 dated 25.03.2023 on the subject cited above. The university has submitted attested copies of the Pimpri Chinchwad University Act, 2022 (**Maharashtra Act No. V of 2023**) notified vide **Notification No.SFU.2019/C.R.106/Uni.4** dated **16.01.2023** wherein **Pimpri Chinchwad University**, Pune, Gut No.44, 46, 48, 49 and 50, Sate Taluka Maval, District- Pune, Maharashtra 412206 has been established as a State (Private) University, by the Govt. of Maharashtra with effect from **16.01.2023 (Notification No.SFU.2019/C.R.106/Uni.4 dated 16.01.2023)**. Accordingly, the name of the university has been included in the list of universities, as maintained by UGC under Section 2(f) of UGC Act, 1956. The list is available at the UGC website www.ugc.ac.in.

The University may note and adhere to the following:

1. The inclusion of the name of the University in the list of universities maintained by the UGC does not by itself allow the University to make admissions in its programmes. This may be done only after creation of required academic and physical infrastructure facilities, including library, laboratories and appointment of teaching and supporting staff as per the norms and standards laid down by the UGC and Statutory Council(s) concerned.
2. The University is requested to submit detailed information (soft copy only) in the prescribed format (available at UGC website at the link (<https://www.ugc.gov.in/oldpdf/proformaprivateuniversities.pdf>) along with supporting documents duly attested by the Registrar of the University within a period of 3 months from the receipt of this letter. The University is also requested to upload the filled in format and appendices on its website by giving a link on the home page so that the information is accessible to the students and general public.
3. After receipt of the Information in the above mentioned format, the following procedure would be adopted by the UGC for inspection of the University:-
 - a. The information received from the University in the prescribed format would be posted on the UGC website within 10 days of the receipt of the information. Comments would be invited from the general public within 1 month thereafter about the information submitted


by the University. The comments received from the general public would be placed before the UGC Expert Committee for perusal.

- b. An Expert Committee would be constituted by the UGC to ascertain whether the University fulfils the criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc. as laid down from time to time by the UGC and other concerned statutory bodies such as AICTE, BCI, NMC, DCI, INC, NCTE, PCI, etc.
 - c. The UGC Expert Committee would inspect the University within 3 months of the receipt of the information for assessment of infrastructure and other facilities available with the University. The report submitted by the UGC Expert Committee would be sent to the University within 2 weeks of the completion of the visit for comments.
 - d. The University may respond to the report within a period of two weeks after its receipt. In case no comments are received from the University within the timeframe, it would be presumed that the University has no comments to offer and further action would be taken on the report. After receipt of comments from the University, the report and comments received from the University, if any, would be placed before a Standing Committee of the UGC. The recommendations of the Standing Committee would be then placed before the Commission for consideration.
 - e. The Commission shall take final decision in the matter. It may require the University to submit further compliance report in respect of the observations/suggestions of the UGC Expert Committee/Standing Committee. The compliance report submitted by the University shall be placed before the Commission for consideration.
 - f. On approval of the Commission, a letter would be issued by the UGC to the effect that the University fulfils the criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc. as laid down from time to time by the UGC and other concerned statutory bodies.
 - g. If it is found that the Private University has, even after getting an opportunity to do so, failed to comply with the provisions of the various UGC Regulations including UGC (Establishment of and maintenance of standards in Private Universities) Regulations, 2003 and suggestions given by the UGC Expert Committee, the Commission may pass an order prohibiting the University from offering any course for the award of the degree and/or the post-graduate degree/diploma, as the case may be, till the deficiency is rectified.
 - h. The UGC may also take necessary action against a University awarding a first degree and /or a post-graduate degree, which are not specified by the UGC and inform the public in general through a public notification.
4. As per the judgment of the Hon'ble Supreme Court in the case of Prof. Yashpal Vs. State of Chhattisgarh, there is no provision to have Regional Centres/off-campus centres beyond the territorial jurisdiction of the State. In view of the judgement of Hon'ble apex court, the University is requested to adhere to the following:-
- a. No off-campus centre(s) is opened by the University outside the territorial jurisdiction of the State in view of the judgement of Hon'ble Supreme Court of India in case of Prof. Yashpal Vs. State of Chhattisgarh.
 - b. In case the University has already started any off campus centre outside the State, it must be closed down immediately. It may also be ensured that any off campus centre within the State shall be opened only as per the provision laid down in the UGC (Establishment of and maintenance of standards in Private Universities) Regulations, 2003 and with the prior approval of UGC.
 - c. The University shall not have any affiliated Colleges.

- d. The University must ensure that there is no franchising of higher education even for the purpose of distance education.
- e. The University has to follow University Grants Commission (Minimum Standards and Procedures for Award of Ph.D.Degree) Regulations, 2022, as amended from time to time.
5. No Open and Distance Learning programmes and on-line programmes shall be started without the prior approval of UGC. Relevant UGC Regulations are available on the UGC website www.ugc.ac.in.
6. The University is empowered to award degrees as specified under Section 22 of the UGC Act through its main campus in regular mode with the approval of Statutory Bodies of the University and Statutory Council(s), wherever required. However, universities can award only such degrees as specified by UGC. The University is required to follow the UGC Notification on Specification of Degrees 2014 and its amendments issued from time to time wherein consolidated list of UGC approved nomenclature of degrees has been specified under Section 22 of the UGC Act, 1956 wherein entry level of each degree and duration of programme have been provided. The approved nomenclature may be followed by the specific area of specialization to be reflected in the parentheses. This notification is available on the UGC website www.ugc.ac.in under the link https://www.ugc.ac.in/pdfnews/1061840_specification-of-degrees-july-2014.pdf.
7. The University is required to follow the UGC (Establishment of and Maintenance of Standards in Private Universities) Regulation, 2003 and other Regulations issued from time to time and posted on UGC website

WHEREAS it is expedient to provide for the establishment, incorporation and regulation of the Pimpri Chinchwad University, Pune, for the development and advancement of higher education in the State of Maharashtra and for matters connected therewith or incidental thereto, for the purposes hereinafter appearing; it is hereby enacted in the Seventy-third Year of the Republic of India, as follows :—

1. (1) This Act may be called as the Pimpri Chinchwad University, Pune Act, 2022.

1. The management shall provide adequate funds for development of infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
2. The Eligibility Criteria for admissions shall be made in accordance with the regulations notified by the Council from time to time.
3. The tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/ guardians of students in any form. If found so, appropriate action as per the notified regulations shall be initiated against the Institution
4. The management of the Institution shall not discontinue any course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the Council.
5. No excess admission shall be made by the Institution over and above the approved intake under any circumstances. In case any excess admission is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution.
6. The Institution shall not have any collaborative arrangements with any other Indian and / or Foreign Universities for conduct of technical courses without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution
7. The Institution shall not conduct any course(s) as specified in the Approval Process Handbook without prior permission / approval of AICTE. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
8. The Institution shall operate only from the approved location, and that the institution shall not open any off campus study centers / extension centers directly or in collaboration with any other institution / university / organization for the purpose of imparting technical education without obtaining prior approval from the AICTE. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
9. The accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or persons authorized by it.
10. Heads of Departments, the teaching and other staff shall be appointed in given time frame and selection shall be done according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the AICTE from time to time. The Institution shall publish an information booklet before commencement of the academic year giving details regarding the Institution and courses / programs being conducted, Fees charged and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education. The mandatory disclosure information, as per directions in the AICTE website / Approval Process Handbook, shall be put on the Institution Website. The information shall be revised every year with updated information about all aspects of the Institution.
11. It shall be mandatory for the Institution to maintain a Website providing the prescribed information. The Website information must be continuously updated as and when changes take place.
12. As per mandatory Disclosure of APH 2024-27(Annexure-18, page180) Institutions must disclose the following information submitted to Council at the Prominent location on its website.
 - i. Department wise availability of Infrastructure along with approved courses and intake approved by the Council.
 - ii. Faculty details: Department wise: Name& Designation of the faculty members/teaching staff along with their qualification, tenure of service in your organization, total experience, Institution should also disclose Student Faculty Ratio, Cadre Ratio.
 - iii. Additionally, Audited Financial Statements for every Financial year on year to year basis.
13. If the Institution fails to disclose the information or suppress and / or misrepresent the information, appropriate action as per the notified regulations shall be initiated against the Institution.
14. AICTE may also conduct inspections with or without notifying the dates to verify specific complaints, to verify adherence to AICTE norms & standards, and to verify any mis-representation, violation of norms & standards, mal-practices etc.
15. The Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid from the Central or State Government.
16. In the event of a student / candidate withdrawing before the starting of the course, the wait listed candidates should be given admission against the vacant seat. NOTE: If the State Government / UT / DTE / DME has a reservation policy for admission in Technical Education Institutions and the same is applicable to Private & Self-financing Technical Institutions, then the State Government/ UT/ DTE / DME shall ensure that 10 % of Reservation for EWS would be operational from the Academic Year 2020-21. However, this would not be applicable in the case of Minority Institutions referred to the clause (1) of Article 30 of Constitution of India.

C. For International candidates, 10% of the total seats is reserved.

D. A candidate seeking admission to a reserved seat shall be required to produce a Certificate of Caste from the competent authority in either English/Hindi/Marathi language.

E. No caste certificate shall be valid unless it is duly stamped, signed and issued by the authority empowered by the State Government/Central Government, from where the candidate has passed the qualifying examination.

F. If a candidate fails to submit the necessary caste certificate as required within the stipulated time, his candidature shall be considered for admission under the unreserved category as per merit.

G. The candidate of the reserved category shall be entitled to be considered for admission under the open category seat according to his preference, subject to fulfillment of the open category eligibility criteria and as per the merit order of the open category merit list.

H. The admission of a candidate of a reserved category on a reserved seat shall be valid subject to the verification of the caste certificate issued to him by the authority empowered by the University on its behalf. In case the candidate fails to submit the caste certificate within the stipulated time or the caste certificate is found to be invalid on verification, he shall not have the right to claim his admission on a reserved seat and if he has already been granted admission then such admission stands cancelled.

I. Reserved seats remaining vacant in any category shall be converted to open category seats. i.e Three percent (3%) of the available seats in each branch shall be reserved, for Physically Handicapped (PH) candidates who can perform the academic activities in the respective branch of admission. Such candidates shall have to submit certificate of disability issued and duly signed by the Civil Surgeon in either English or Hindi or Gujarati language. This is subject to verification of the disability in person by the medical officer of the University, who will also certify whether the candidate is capable of pursuing four-year study program at the University.

Explanation "Physically Handicapped (PH)" means a person suffering from not less than forty percent (40%) of any disability as certified by a competent medical authority or prescribed by Government norms.

J. The candidate of PH category shall be entitled for admission to the SC / ST category seat according to his / her preference subject to fulfillment of respective category eligibility criteria and as per merit order of respective category merit list.

K. Ten percent (10%) of the available seats in each branch shall be reserved for Economic Weaker section (EWS) candidates who can perform the academic activities in the respective branch of admission. Such candidates shall have to submit the certificate of Income issued and duly signed by the respective Government body in either English/Hindi/Gujarati language. This is subject to verification of the Income certificate in person by the Admission officer of the University.

L. Out of the total approved intake capacity, forty percent of the seats are reserved for the students having domiciled in the State of Maharashtra.

M. The Pimpri Chinchwad University shall follow the regulations amended on reservation policy prescribed by the Government of Maharashtra from time to time.

Application Process

For admission, a candidate shall apply online or direct, for the application of his candidature, on the University website, within the time limit specified by the University. (Please visit the University website for the online application procedure i.e www.pcu.edu.in.)

The University shall announce, by advertisement in some leading national newspapers, on its official website, and by similar other means as it may consider necessary, the date of application, the last date for submission of the application form, the programs offered, and such important information.

Merit List

For the purpose of admission on All India Seats the University will prepare the inter- se merit list of the candidates who have applied for admission in the manner prescribed by the University, within the prescribed time limit and who are found eligible (subject to verification) at the time of counseling for admission under these rules.



Admission Procedure

The admission procedure shall be in the following manner :

The University shall prepare a merit list of the eligible candidates who have applied for admission under these rules.

- a) The provisional admission shall be offered through online and direct modes as per the schedule.
- b) An offer of admission shall be made based on merit, the category of the candidate, and the availability of seats.
- c) The candidate can freeze the admission for a program offered to him upon payment of the fees as prescribed, after which he/she will not be eligible for an offer of admission in any other program. If a candidate is offered provisional admission in a program as per his/her preference but does not accept it, he/she can be considered for subsequent relevant rounds of admission, but only for the branch/branches of his/her higher preference, if any.
- d) The provisional admission will be confirmed only after verification of the original documents and personal and academic credentials of the candidates, viz., identity, age, academic qualifications, and reservation category, as per the schedule to be announced on the website.
- e) It shall not be obligatory to give admission to a candidate if he fails to secure admission online as prescribed.
- f) No changes in branch preference shall be possible after the last date of submission of an online application.

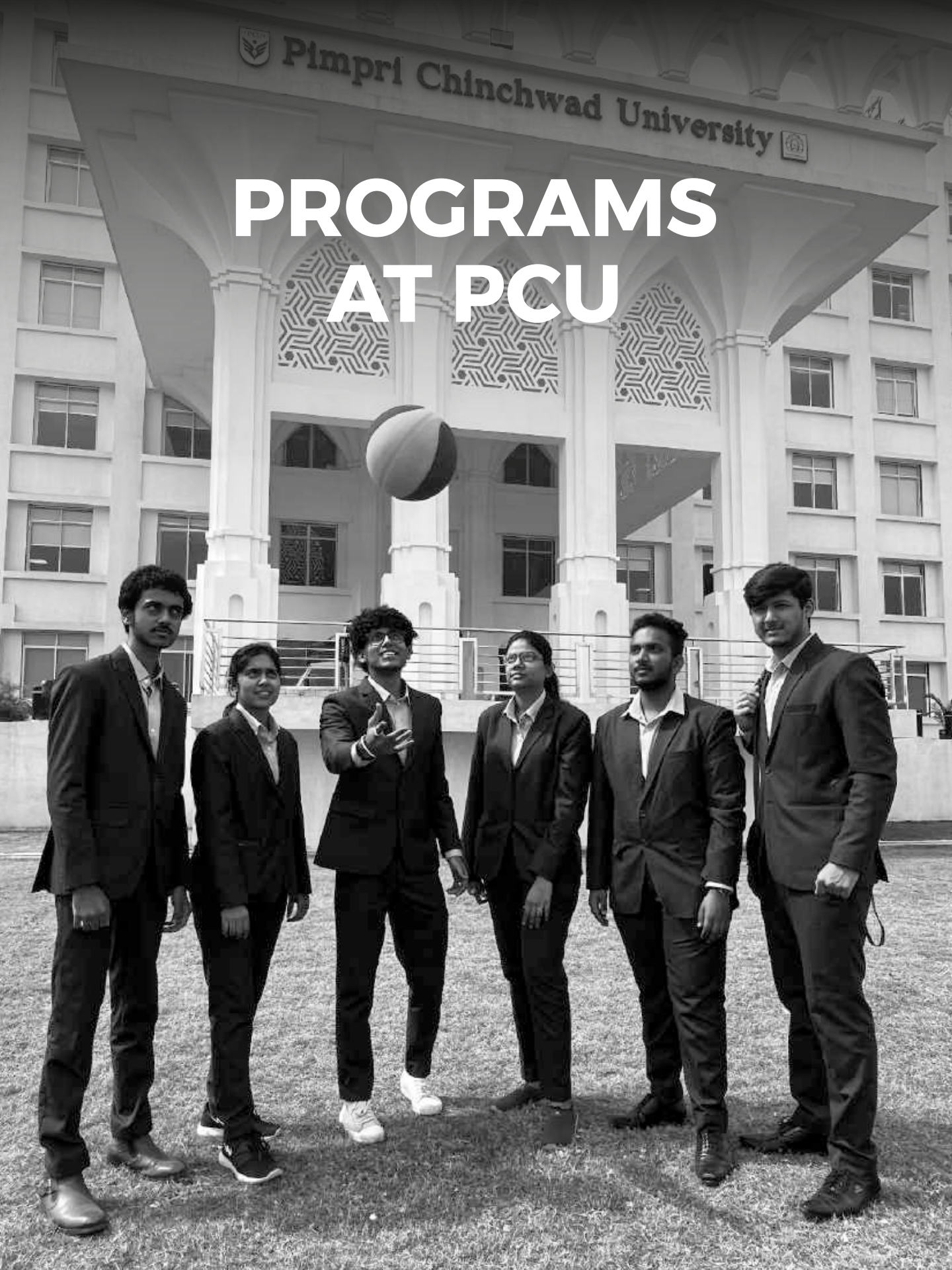

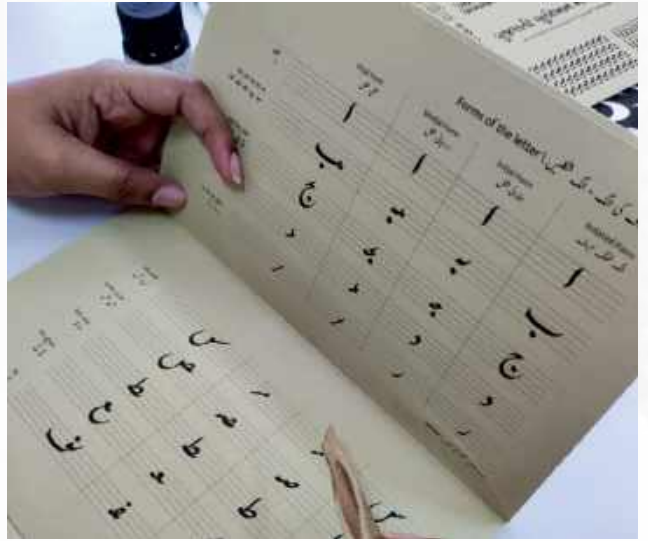
