Item No. 01: Welcome note by Vice-Chancellor (I/c)

Dr. Manimala Puri, Vice Chancellor (I/c) welcomed all the members and experts from academics and industry present for the meeting. In her brief talk she informed members about academic activities, progress, events conducted at the University during first year of the establishment of the University.

The members have taken a note of the same.

Item No. 02: To consider and approve the minutes of the 2nd Academic council meeting held on 11.05.2024 and to take note of the action taken Report.

Discussion: Dr. Sudeep D. Thepade, Pro-Vice-Chancellor informed the members that the MoM of the previous AC-02 was circulated by the Registrar office and requested the members to give their consent & confirmation to the MoM.

Item No. 03: To take a review on Admission Status of 2024-25.

Discussion: Dr. Sudeep D. Thepade Sir briefed Intake and program wise admitted student's details of AY 2024-25, also mentioned the rise of admission count from last year to this year.

Dr. Mukul Sutaone Sir, our special invitee asked to provide the comparative status of admission for AY 2023-24 & 2024-25, considered entrance tests and accordingly Merit list of the Admitted students.

The Members after due deliberations took a note of the same as annexed in Annexure_B

Item No. 04: To consider and approve the modified Course Structures of the programs with inclusion of MOOCs courses as approved by the respective BoS and a subject on 'AI' in all UG programs.

Discussion: Dr.Sudeep D. Thepade briefed about the modified course structures of the programs, elaborated the additional inclusion of MOOCs courses in each SEMESTER to improve self-learning ability of the students by adding credits in CGPA, with clear 'R & R' and by taking regular reviews with LOG Book.

These course structures were approved by the respective BoS and recommended to Academic Council for approval.

Dr.Sudeep D. Thepade sir added that PCU has initiated certification courses through Coursera, REDHAT, NPTEL, EduSkills, Google, Edex and IIT spoken Tutorials to fit all disciplinary requirements and to increase the employability of the Students by this value additional courses, around 2 to 4 credits of these MOOCs to weightage has been added. Also quetion based assignment taken time to time.

Dr. Sutaone sir suggested that MOOC courses should be in augmented learning mode. There should be a core teacher physically for CORE subject with latest technology. Also advised to make compulsorily at least 2 NPTEL courses per student, it will make a habit to learner without a teacher.

The members have acknowledged the modified course structures with inclusion of MOOC courses.

For internal monitoring purpose, LOG books were initiated to keep all track of each student

The Members after due deliberations took note of the same and passed the following resolution unanimously:

(Resolution No.: AC/2024/03/4): "RESOLVED THAT the Academic Council hereby approves course structure policy as annexed in Annexure_C

Item No. 05: To approve new school for BCA, MCA and B.Sc. Computer Science (cyber security) programmes named as 'School of Computer Applications" and renamed School of Media & Communication as 'Pune School of Media and Communication'

Discussion: Dr. Sudeep Thepade recommended the changes in School name for BCA, MCA programmes from the School of Engineering and Technology to School of Computer Applications this would be operationally & administratively easy to handle academics. The earlier BCA, MCA BoS were conducted separately under School of Engineering & Technology and now it will continue with the School of Computer Applications.

Another, B.Sc Computer Science (Cyber Security) programme has also transfer under the School of Applications which was run under School of Sciences with B.Sc (Clinical Psychology) and B.Sc (Nutrition & Dietetics) programs. It is difficult to manage different manpower in one school.

The Members after due deliberations took note of the same and passed the following resolution unanimously:

(Resolution No.: AC/2024/03/5): "RESOLVED THAT the Academic Council approves the introduction of new School from the Academic Year 2024-25 with existing programes be and is hereby recommended to Board of Management for consideration.

Item No. 06: To approve new Programs to be commenced from AY 2025-26.

Discussion: Dr. Sudeep Thepade informed the members that looking at the NITI AAYOG's recent report on electronics powering India's participation in Global value chain and the mission which Government of India has launched as India's semiconductor mission, we look forward to start B. Tech Computer Science and Engineering course with specialization in Semiconductor Technology i.e 'B. Tech Computer Science (Semiconductor Technology)' which have anticipated that the design part of the semiconductor would be covered in curriculum along with basic computer science courses. Also recent visits had in South Korea and visits of South Korean University officials to PCU for further corrodnation with respect of technology, we wish to seek approval from academic council and their views on this for few divisions based on the response of the students.

One more proposal wish to put forth that is 'MBA (Business Analytics and Artificial Intelligence)' because all business houses are now getting data driven and they are adapting the data as prime valuable source or important asset in business. So in all aspect of growth of business, the strategies are getting formed around analysis of available multimodal data.

There was a another proposal from Tata Motors as they approached us to start 'Diploma In Mechatronics Engineering'. This could be a (2) two year course for the students who have completed ITI with 12 and (3) three years course for the students who have completed 12 std. This would be exclusively for work force of Tata Motors for their upskilling who are working at Tata Motor.

Dr.Thepade assure that in coming academic council meeting will be coming up with detailing of curriculum because all these courses would be floated from July 2025 onwards.

After due discussions and deliberations members suggested the following resolution unanimously:

Dr.Prashant Bartakke suggested that Semiconductor Technology requires many transistors, equipment's and advised to invite experts from Industry to deal with simulations and new semiconductor design technology. And program name could be B.Tech in Semiconductor Design Technology instead of mentioning Computer Science.

So, in AY 2025-26 on students response for **B.Tech Computer Science (Semiconductor Technology)' will** explore more for B.Tech in Semiconductor Design Technology.

Dr. Sutaone suggested for new programme, MBA (Business Analytics and Artificial Intelligence) that, Informatics is a bigger domain than Analytics so programme name could be MBA (Business Informatics and Artificial Intelligence)

(Resolution No.: AC/2024/03/6): "RESOLVED THAT the Academic Council approves the introduction of new programmes from the Academic Year 2025-26 be and is hereby approved and recommended to Board of Management for consideration.

Item No. 07: To consider the charges of Transfer Certificate, Migration certificate, Duplicate Identity Card, Duplicate Transfer & Migration Certificate.

Discussion: Dr. Sudeep Thepade recommended to consider some minimal charges for Transfer certificate, Migration certificate, Duplicate Transfer / Migration Certificate and Duplicate Identity Cards compared with what other universities are charging.

The Members after due deliberations took note of the same and passed the following resolution unanimously:

Dr. Sudeep D.Thepade informed that the examination department had conducted the TERM END Examination for Academic Year 2023-24 and briefed the members on result analysis and all results are correlate with quality of the program and same is annexed in **Annexure_E**.

Also briefed that Exam. dept. had conducted special examination for failure cases as an additional attempt as per following pattern of examination,

c. Result Analysis Nov-Dec. 2024

Dr. Sudeep D.Thepade informed that the examination department had conducted the ODD SEM Examination for Academic Year 2024-25 and briefed the members on result analysis and same is annexed in **Annexure_F**.

The Members after due deliberations took note of the same and passed the following resolution unanimously:

(Resolution No.: AC/2024/03/8): "RESOLVED THAT the examination fees, TERM END exam 2023-24 and Result analysis for Nov-Dec 2024 mentioned in Annexure_D, Annexure_E and Annexure_F respectively be and is hereby approved.

Item No. 09: To discuss Students feedback of respective Schools for ODD SEM AY 2024-25.

Discussion: Dr. Sudeep D. Thepade briefed academic council memebrs about average student feedback. The feedback was collected twice first after four weeks of academic delivery and second after conclusion of academics. This feedback used for improvement of perspective faculty member. All Head of Schools had discussed and passed it to each faculty members.

The Members after due deliberations took a note of the same as annexed in Annexure_G

Item No. 10: Reporting Items

i. MoU's

Dr.Sudeep D. Thepade briefed about the MoU done since January 2024 to till date with Indo Campasss LLP, Data Flair Web serivces Pvt.Ltd., Jahangir Hospital, Yuvana wellness cohesive care LLP, IAPEN India Association, NSE Academy, Anifilms College of Arts and Design, Atpat Production, Global Technology Network (GTN), Cytolife Agritech Pvt.Ltd., Mumbai, Eduskills, Beauty & Wellness Sector Skill Council (B&WSSC), National Cooperative Union of India (NCUI).

Schools HoD's like Management, Schools of Sciences, Media and Communication was enlightened the purposes of the MoUs with renowned Industries.

Dr.Prashant Bartakke suggested to keep time to time evaluation mechanism for all MoU's. Also conveyed that to plan activities in each month and initiate accordingly.

Dr.Sudeep D. Thepade informed that the UGC 2(f) visit held on 5th & 6th September 2024 and follow up of the same has initiated.

iii. BCI Approval

Dr.Sudeep D. Thepade informed that the Bar Council of India approval was done in last academic council for 60 LLB and 60 BA LLB and received interim approval from BCI to start Academics from 2024-25.

The Members after due deliberations took a note of the same.

iv. Appointed teaching staff & Teaching staff requirement for AY 2025-26.

Dr. Sudeep D. Thepade informed the count of appointed teaching staff and seek approval from the academic council members to have 142 additional recruitment considering 1:20 OR 1:25 faculty student ratio based on those courses and as per statutory requirements.

The Members after due deliberations took note of the same and passed the following resolution unanimously:

(Resolution No.: AC/2024/03/10(iv)): "RESOLVED THAT mentioned requirement of Teaching staff as annexed in Annexure_H be and is hereby approved.

v. Awards received - Eduskills, Times.

Dr.Sudeep D.Thepade highlighted very happily with honourable academic council members that the few awards received by the University,

vi. Enrollment Number of PCU Students

Dr.Sudeep D. Thepade informed the formation of enrolment number for the students who have admitted for first academic year in the University.

The Members after due deliberations took note of the same and passed the following resolution unanimously:

vii. AICTE -Extension of Approval for AY 2025-26.

Dr.Sudeep D.Thepade highlighted that the process for Extension of Approval for AICTE approved programmes i.e for BBA, BCA, MBA and MCA has been initiated for Academic year 2025-26.

The Members after due deliberations took a note of the same.

viii. PCU Events

Dr.Sudeep D. Thepade informed that the PCU is full with student development activities and events. Few of the events got conducted but very few we have listed here,

ix. Recognition of Prior Learning (RPL) Rules & Regulations

Dr.Sudeep D.Thepade briefed about Recognition of Prior Learning (RPL) Rules & Regulations, the objective of this policy is to provide a framework for facilitating the effective & efficient inter university transfer of the students with lateral entry admissions as well as transfer of credits from other Universities of India and abroad. Applicable programs and eligibility are mentioned in RPL, R & R which is on more than 80% credits we can directly admit the student here. If number of credits which are 70% same, one of MOOCs which would be recommended by this RPL committee and they will have to complete those 10% credits after joining the university team for two and a half months to formalized the process.

And all the time head admissions will be the secretary of this committee, they would be calling this meeting with the help of the committee members who are Professors at University and Student section. And if a professor do not happen to be from the discipline for which the decision is done or decision is to be taken from the head of school of that respective discipline would be in this RPL committee. And the moment we receive application from any student in a fortnight we will be able to revert back to that student where the admission could be considered or could not be considered.

The Members after due deliberations took a note of the same.

(Resolution No.: AC/2024/03/10(iv)): "RESOLVED THAT academic council members have noted the system as annexed in Annexure_J be and is hereby approved.

Dr. Sudeep D. Thepade elaborated the placements activities have started for PG students and 08 MBA students have placed out of 79 and 06 MCA students out of 69 are in pipeline to be placed.

Placement activities are initiated with the help of regular training program on aptitude, career catalyst program etc. for all UG and PG programmes.

Even School of Computer Applications came up with a career catalyst program, a sort of finishing school before starting a placement season. Initially before beginning of placement season, willingness from students would be obtained.

The Members after due deliberations took a note of the same.

xiii. SAP certifications

Dr. Sudeep D. Thepade informed that SAP certifications were promised to MBA International students. The training programmes got conducted and most of the students took clear the certifications.

The Members after due deliberations took a note of the same.

xiv. Certifications

Dr. Sudeep D. Thepade briefed on one of the important aspect in various digital platforms like Red Hat Academy, NPTEL, Eduskills, Google and Edex for management school, IIT spoken tutorials and Coursera.

All schools and students are having a number of certifications. These were not formalized as credit transfer. Now, coming semester onwards, the credit is formalized. But still around 4720 certifications, also 91 students could complete and faculty members could get completed that becomes additional learning and certificate.

Dr.Sudeep D.Thepade informed that by assuring that everything is going in place, we have attempted for few of the courses in last academic year but due to infrastructure and get very few interests for the following Programmes we wish that this year the intake for these courses could be zero. When so ever the infrastructure would be available, we would be settling up with the existing courses.

Then in future, we will again approach to academic council for getting these courses floated because in admissions for all these courses were zero in academic year 24-25.

- 3. BA (integrated with civil services exam)
