### 1. Welcome note by Chairman - Pimpri Chinchwad Educational Trust

Shri. Dnyaneshwar P. Landge welcomed the members of Governing Body and thanked them for their kind acceptance as members of the Governing Body of Pimpri Chinchwad University, Pune.

### 2. The introduction of the Pimpri Chinchwad University and its establishment by PCET's Vice-Chairperson

Smt. Padma M. Bhosale apprised the establishment of University as per the State Private University ACT, Government of Maharashtra. She explained the entire process done by the Sponsoring Body from Application to Approval of Pimpri Chinchwad University, Pune.

## 3. Acknowledgement of nomination and appointment of "President - Pimpri Chinchwad University, Pune"

Shri Vitthal S Kalbhore apprised the committee that the Sponsoring Body in it's Board Meeting held on February 13, 2023 vide agenda No. 1173, nominated Shri Harshawardhan Shahajirao Patil as a First

President of the Pimpri Chinchwad University, Pune and Resolved that Shri Harshawardhan Shahajirao Patil will be "President" of the Pimpri Chinchwad University, Pune. His appointment has been done in context with the Pimpri Chinchwad University, Pune ACT.

The members have noted the agenda point and congratulate the newly appointed President.

### 4. The Formal Introduction of Governing Body Members – All Members

Shri Harshawardhan Shahajirao Patil have thanks to the sponsoring body and Governing Body members. He introduced the members to the forum and welcomed them.

## 5. The Introduction of Governing Body Key Responsibilities and Role of Governing Body in University Operations - President (Section 21 of PCU Act)

Shri Harshawardhan Shahajirao Patil, apprised that the Governing Body of the University is the Supreme Statutory Authority and oversees the overall governance system of the University. The GB provides general superintendence, quality control and directions and to control functioning of the University. The GB is to lay down the policies to be followed by the University. The Governing Body meets at least thrice in a calendar year minimum once in every 4 months and the quorum for meetings of the Governing Body is five.

The Members have taken a note of it and assured their contribution for University Operations.

### 6. Acknowledgement of the Establishment of Endowment fund of Rs. 10 Cr.'s (Section 8 of PCU Act)

Shri Vitthal S Kalbhore apprised the committee that the Sponsoring Body has fulfilled the Section 8 of Pimpri Chinchwad University, Pune Act. The Endowment Fund of Rs. 10 Crores has been established and the Fixed Deposit of the said amount have done with Indian Overseas Bank.

The Fixed Deposit has been lien with "Director - Higher Eduction, Pune" to follow the Act.

He also informed to the Governing Body that the Interest Receivable against the Endowment Fund shall be utilised for University Infrastructure Development purposes only.

## 7. The Formal Approval of Statutory Appointment of University officers; Vice-Chancellor, Deans of Faculties, Registrar, Controller of the Examination, Chief Finance & Account Officer (Section 14, 15, 16, 17 & 18 of PCU Act);

Shri Harshawardhan Shahajirao Patil, apprised the Governing Body Members that pursuant to Section 11 of the Pimpri Chinchwad University, Pune, Pune Act, the following shall be the appointed as the officers of the University, namely:—

- The Chief Finance and Accounts Officer
- The Controller of the Examination

Shri Harshawardhan Shahajirao Patil informed the members that the University has initiated the process of appointment of University officers which may take couple of weeks to complete the procedure as per the statutory guidelines. Till the time the University has decided to appoint incharge Vice-Chancellor to ensure smooth establishment and functioning of the University.

The Members after due deliberations took note of the same and passed the following resolution unanimously:

### 10. To approve the draft of Academic Regulations (Section 35 of the PCU Act)

Dr. Mani Mala Puri have informed the Governing Body that the University has prepared the draft Academic Regulation.

The members have seen the draft copy of Academic Regulations and suggested few changes as per the latest National Credit Framework and National Higher Education Qualification Framework.

The Members after due deliberations took note of the same and approved the Academic Regulations with the changes suggested by the Members.

### 12. To approve to start University from Academic Year 2023-24

Dr. Mani Mala Puri appraised the Governing Body that the Department of Higher and Technical Education, Government of Maharashtra have issued the GR on Pimpri Chinchwad University, Pune became a operationalised on 16th May 2023.

She explained to the Governing Body on readiness of the University to start its operations from Academic Year 2023-24 and approve the same.

The Members after due deliberations took note of the same and passed the following resolution unanimously:

She also explained that the The fee of each programme has been decided taking in view the fee charged by other Universities/Institutes in Maharashtra especially in Mumbai-Pune Region for similar courses. The fees is fixed on unit cost method although the expenditure may be very high for first years but fee is normalized keeping in mind the revenue for next 5 years and recurring expenditure for next 5 years.
